ORDINANCE NO. A-14

March 18, 2013

BE IT ORDAINED BY THE BOARD OF ALDERMEN  
OF THE CITY OF NEWTON AS FOLLOWS:

That the Revised Ordinances of Newton, Massachusetts, 2012, as amended, be and are hereby further amended with respect to Chapter 11 **RECYCLING AND TRASH\***

- I. Delete the caption of Sec. 11-5 and insert in place thereof the following:

**Sec. 11-5 Trash, Garbage—Permit required to transport; recycling services required.**

and

Add to **Cross reference**—after “Licensing and permits generally, Ch. 17; “ the words “G.L. c. 111 sec. 31A.”

- II. Insert in the first sentence of Sec. 11-5 the words “trash or” before the word “garbage”

- III. Insert in the second sentence of Sec. 11-5 the word “such” before the word “collection” and delete after the word “collection” the words “of trash”

- IV. Insert in paragraph (h) of **Sec. 11-7. How trash to be placed for collection; weight of receptacles.** after the words “subsequent offenses” the words “occurring in any three hundred sixty-five (365) day period.”

And

Add “**Cross reference** – general penalty, §1-6; civil fines, §20-21.”

- V. Insert in paragraph (i) of **Sec. 11-8. How recyclable materials to be placed for collection.** after the words “subsequent offenses” the words “occurring in any three hundred sixty-five (365) day period.”

And

Add “**Cross reference** – general penalty, §1-6; civil fines, §20-21.”

- VI. Insert in the second sentence of paragraph (a) of **Sec. 11-9. Participation in and enforcement of recycling and trash program.** after the words “subsequent offenses” the words “occurring in any three hundred sixty-five (365) day period.”

And

Add “**Cross reference** – general penalty, §1-6; civil fines, §20-21.”

VII. Insert in paragraph (c) of Sec. 11-10. **When trash and recyclable materials to be placed for collection; carts to pass through streets only once.** after the words "subsequent offenses" the words "occurring in any three hundred sixty-five (365) day period."


And

Add "Cross reference – general penalty, §1-6; civil fines, §20-21."

VIII. Delete the caption of Sec. 11-11 and insert in place thereof the following:  
**Sec. 11-11 Registration for transporting garbage through Newton.** and delete in the first sentence after the word "transporting" the words "trash and/or recyclable materials" and insert in place thereof the word "garbage"

IX. In **Sec. 20-21. Enforcing persons and revised ordinances subject to civil fine.** delete in paragraph (f) DEPARTMENT OF PUBLIC WORKS: all references to "first day", "2nd day", "3rd day and each day thereafter" and substitute in place thereof "First offense per 365-day period", "Second offense per 365-day period" and "Third offense and subsequent offenses per 365-day period"
