ORDINANCE NO. A-59

May 4, 2015

BE IT ORDAINED BY THE BOARD OF ALDERMEN
OF THE CITY OF NEWTON AS FOLLOWS:

That the provisions of the Revised Ordinances of the City of Newton, Massachusetts, 2012, as amended, be and are hereby further amended in respect to **Chapter 29 WATER, SEWERS AND DRAINS**, as most recently amended by Ordinance A-52, dated December 15, 2014, as follows:

1. In Section **Sec. 29-36. Rates, schedule.**, insert in subsection (a)(1) pursuant to Ordinance A-52 the following, effective July 1, 2015:

Six dollars and ten cents (\$6.10) per hundred cubic feet for consumption from 0 to 10 hundred cubic feet;

Seven dollars (\$7.00) per hundred cubic feet for consumption from 11-25 hundred cubic feet;

Eight dollars (\$8.00) per hundred cubic feet for consumption from 26 to 60 hundred cubic feet

Ten dollars (\$10.00) per hundred cubic feet for consumption above 60 hundred cubic feet

For outdoor meters the rate shall be eleven dollars (\$11.00) per hundred cubic feet regardless of the amount of consumption.

2. In Section **Sec. 29-80. Sewer/Stormwater Use Charge.** insert in subsection (c) (1) Sewer rates pursuant to Ordinance A-52 the following, effective July 1, 2015:

Nine dollars and twenty-five cents (\$9.25) per hundred cubic feet for consumption from 0 to 10 hundred cubic feet;

Nine dollars and seventy-five cents (\$9.75) per hundred cubic feet for consumption from 11 to 25 hundred cubic feet;

Eleven dollars and fifty cents (\$11.50) per hundred cubic feet for consumption from 26-60 hundred cubic feet


Thirteen dollars and twenty-five cents (\$13.25) above per hundred cubic feet for consumption above 60 hundred cubic feet;

3. Delete subsection 29-80(b)(1), Stormwater rates, in its entirety and insert in place thereof the following, effective July 1, 2015:

(b) Stormwater flat fees:


(1) Such stormwater use bill shall be issued on an annual basis as follows:

- a) For properties the principal use of which is residential\$75.00
- b) For all other properties\$200.00
